John Brisby QC and Tom Gentleman are planning to scale three of the highest peaks in the Balkan mountains, during an epic two-day hike, raising money for Friends of Bulgaria. On 20 and 21 August, weather permitting, they will climb Mount Botev (7,795 ft), Kupena Peak (7,116 ft) and Ambaritsa (7,106 ft), making their way for many miles along the deserted, windswept Balkan ridge, on foot for twelve hours at a stretch. The aim is to raise money for one of Friends of Bulgaria's most worthwhile causes, supporting the music and dance programme of the Nezabrvaka Home for abandoned children in the Bulgarian city of Stara Zagora. This is a residential home for children of 3 to 7 years old. Without the support of Friends of Bulgaria, these abandoned children would have no opportunity for music, as the state does not provide music lessons. The charity pays for a teacher who offers 20 hours of music and dance lessons every week. The children perform regularly, giving them an invaluable chance to interact with each other and those outside the home, gaining confidence and honing their social skills, and most importantly, having fun. Friends of Bulgaria was established in 1991, at a time of turmoil and economic crisis in Bulgaria. Since its foundation, it has raised more than £300,000 for charitable causes in Bulgaria. In its early years, it provided humanitarian aid, supplying desperately needed equipment and pharmaceuticals for hospitals and children's homes. As Bulgaria has grown more prosperous and stable, the charity has focussed on projects which support and improve the lives of disadvantaged children, through the provision of art and music teaching, mentoring schemes and social clubs for children in institutional care in Bulgaria. Friends of Bulgaria has no paid staff, and no administrative costs, so all gifts go straight to the causes which the charity supports.

Music and dance for Bulgarian children's homes

For 10 years Friends of Bulgaria has been supporting the music and dance programme of Nezabrvaka Home for abandoned children in the Bulgarian city Stara Zagora. With grants of up to £3,500 per year Nezabrvaka managed to maintain daily rehearsals for its children who are 3 to 7 years old. Friends of Bulgaria pays for a teacher who offers 20 hours of music and dance lessons every week. This is invaluable experience for children who have no or very limited contact with their parents. The state does not provide music lessons. In the words of the Director Radina before the programme started the children, often bored, were only asking when they are going to eat. And food is plentiful in the home. Now they are asking when is the next rehearsal.

Thanks to the music and dance programme the children from Nezabrvaka develop vital social and physical skill, they gain confidence, both in interacting with each others and people from outside the home. The children perform in front of public on average every two weeks. For 2014 they have a programme of 25 events outside the home.

Friends of Bulgaria is now raising funds needed to continue the music and dance programme at Nezabrvaka. We also want to extend this valuable experience to other homes in the country. Depending on the amount we raise we will be able to make many other children happy, lively and confident.
